Auditor's Comments: The county supplied a copy of a paper tape for Machine 5121961 in Absentee/Failsafe with a single ballot on it. That tape shows the machine was opened on 9/12/2010 at 4:03 PM and closed at 9:14 AM on 10/12/2010. The section of the tape supplied does not indicate which precinct the vote was cast.

> The Event Log (EL152) shows that the county opened the machine for voting on 10/12/2010 at 09:49 AM after sucessfully clearing and testing the flash card that contains the audit data. The machine was closed on 11/02/2010 at 6:13 PM with 138 ballots cast. The audit data shows that 137 ballots were cast in the Absentee precinct on this machine and 1 in the Failsafe Precinct. The Event Log also shows that machine 5138517 was opened on 10/12/2010 at 09:54 AM and closed on 11/02/2010 at 4:43 PM. The audit data shows that 116 Absentee ballots were cast and 1 Failsafe ballot was cast on this machine.

The EL68A System Log shows that 118 Optical ballots were read into the Absentee Precinct from the M100 on 11/02/2010 at 6:06 PM. At 7:21 PM 253 iVotronic ballots were read into Absentee from PEBs giving a total of 371 ballots followed by one more from PEBs within the same minute for a total of 372 ballots. There is no notation of a manual entry in the System Log. The EL68 Manual Entry Log contains only entries for the number of registered voters in each precinct made on 11/05/2010 at 8:31 AM.

On Certification day, 11/05/2010, the database was cleared at 8:08 AM, 118 Optical Ballots read in from the M100 at 9:15 AM. At 9:40 AM 253 iVotronic Ballots were read in from PEBs and 1 more from a PEB within the same minute.
